# From the President's Desk

As many of you know, our long-time Executive Director Bill Flood retired on May 1, 2008. What most did not know was that Bill kept on going as he approached his 85th birthday. Bill soldiered the incomprehensible path of leading BCS YES! because of his strong commitment to keep providing direct care to disadvantaged youth.

At his tribute luncheon in June, Bill acknowledged that his retirement gave him more time to watch television. And what he saw caused him severe heartburn. Marching across today's screen are frequent and poignant appeals for funds to support the work of organizations devoted to protecting pets – "puppy dogs and kitty cats" as Bill put it.



Virtually missing are appeals to help the very helpless children

and youth of the urban complexes in which most of us live. As Bill bluntly asked, "Are puppy dogs and kitty cats more important than the kids among us"? Are the youth of our cities, children with few advocates and scant media attention, worth less than puppy dogs and kitty cats?

Here are some disturbing observations that emerge from the Philadelphia Department of Human Services' annual needs-based budget for 2009:

- National trends show an increasing trend toward poverty among children...in Philadelphia, slightly more than 25% of the population falls under the federal poverty line.
- Philadelphia has an estimated 128,332 children under age 17 living in poverty, or over one-third (34.6%) of the 370,562 children under 17.
- Frequently children who are poor live in communities where resources are scarce and systems, such as education, health care and behavioral health, are under-funded.
- The School district of Philadelphia annually identifies 90,000 children who have eight or more unexcused absences.
- Of all placements [to private providers such as BCS YES!] as of 6/24/08, children age 13 and older make up 46% of all dependent placements.

Leonard Pitts Jr., a reporter for The Miami Herald, put it this way in the concluding article of his 19-month-long series on poverty:

"Consider the math instead. If [an] investment of \$3,500 per annum creates a functioning adult who pays taxes and otherwise contributes to the system, why pass that up in favor of creating, ten years later, an adult who drains the system to the tune of \$60,000 a year for his incarceration alone, to say nothing of the other costs he foists upon society. How does that make sense?"

So, the next time you watch a heart-tugging appeal for abandoned pets, we hope that you will remember the abandoned teens growing up at BCS YES! and give generously to a cause of equal or greater human value.

# The Man & His Smile



hat better defines a person's sincerity than a smile? It is a simple expression with endless information about the one behind it. If you study people enough, you can learn much about their character through the other window into the soul; the smile.

When I met Dr. Flood, I didn't get my opinion in a meeting, a memo, policy, or the endless resumé of good deeds he has done for so many prior to coming aboard as the Executive Director. I found it in his warm, broad smile; one so radiant it brings out the kindness in one's eyes; the true window to the soul. It is genuine, filled with faith and light, and finds a way to bring out the same in others.

While you don't really know someone merely through one facial expression, I have found it to be an accurate measurement of

Dr. Flood's character. In getting to know this fearless, tireless, faithful leader over the years, it was obvious to me that his smile did not fail his character. Dr. Flood always said, "If the children need it, get it done!" His concern spanned beyond the children to those charged with the care of the children. After all, the best way to take care of those in need is to look after their caretakers. And he did so, in struggling times, with great concern for all. My favorite statement in all staff meetings was the last thing he said to us before we would leave the room: "Thank you for all you do." Most employers forget to do that, and those that do, well they don't always mean it. But I knew he truly meant it; every time.

I must add that his fierceness appears to be an equal and balanced side to the care and concern noted above. Do not mistake kindness for weakness. He did not always have reason to smile at us, nor did he. This beautiful expression was earned, which made it even more genuine. Dr. Flood has always been defined, in my mind, by a careful balance of concern and discipline. Respect and "the smile" were always earned.

Dr. Flood will always be a valued member of our family at BCS YES! He is admired and loved. So, without turning this into a novel, I only have one more thing to say: Thank you, Dr. Flood, for all that you do. This is said with a warm, broad, loving smile.

#### From the BCS Archives

The institution was incorporated January 4, 1879. On March 15, 1880, the temporary home at the southeast corner of Seventeenth and Diamond Streets was opened. Mrs. J. J. Stadiger was the first president of the Board of Lady Managers...Dr. Benjamin Griffith was elected a member of the Board of Trustees of the Orphanage in January, 1883, about which time Mrs. Griffith became a member of the Lady Managers, of which Board she was elected president in 1884. At that time there was but one orphan, a matron, and a servant girl.

# Bill, as Honoree makes appeal



n May 2nd the Staff of BCS YES! received a memo from the Board of Directors announcing that it had regretfully accepted the resignation of Dr. William E. Flood as Executive Director. After 34 years of service to Baptist Children's Services on the Board and Staff, Bill had decided to begin his retirement years. On June 25th BCS paid tribute to a great administrator, advocate, and friend at the Crowne Plaza Hotel in King of Prussia. Receiving a shower of praise and well-wishes from over a bundred in attendance, Bill graciously delivered the following remarks.

I've been watching a lot of television lately. No, I'm not totally corrupt, not yet! I've watched the news and one of the things that has been so expressive of the news commentators is their concern with puppy dogs and kitty cats, showing them in such situations with the caveat that if you don't do

something, we're going to have to put them to sleep. So send in your money. Save the puppy dogs and the kitty cats.

Some of you know that I am a great pet lover. I've been surrounded by them most of my life. The thought occurred to me as I saw those images, send money to save the puppy dogs and the kitty cats, that someone has to speak up for the kids. Somebody has to stand up and say, "Give money for the kids. They are our future generation."

I would surmise that many might look into their wallets and checkbooks and give something for the puppy dogs and the kitty cats. But everyday on the streets of Philadelphia and the surrounding counties there are children in desperate need. And well they may die before reaching majority.

I'm proud of Baptist Children's Services and BCS YES! And I would hope that when BCS says there's a kid in need, that you'll write a check and give a contribution. Not for puppy dogs, not for kitty cats, but for children so desperately in need.

The Board of BCS YES! has to be commended for underwriting the support of this Agency. There are people who work on the Staff of BCS who serve without recognition and who over the years have not received adequate compensation for the work they do. They work long hours and have love in their hearts for the kids they serve. They are at best the unseen support of BCS. I want personally to commend them for the work that they do.

I'm proud of the Baptist churches who serve the needs of kids. I'm proud of the work and concern that we all have in the future of this country and its interest in the needs of kids and not just puppy dogs and kitty cats. Thank you for coming out. God Bless and thanks very much.
